7.1 MOTION WITH NOTICE - COMMERCIAL INFORMATION ON RECYCLABLES PROCESSING

Cr Schuster gave his reasons for the motion which is associated with the CEO report item 9.3 RRRC Business Marketing Plan 2017.

The SMRC intends to formally submit tender responses on commercial terms directly or indirectly (by joint tendering with waste collection companies) to local governments, at least including the Cities of Cockburn and Kwinana (which I believe intend to tender for recyclables collection and processing in the next 12 months) for processing waste at the RRRC Material Recovery Facility in 2017 and beyond. Any proposed fee structure identified in the RRRC Marketing Plan may disclose commercial information pertinent to these tenders, and place the relevant Regional Councillors and staff in a difficult position.

Councillors and Member staff will be aware that the SMRC recently (in co-operation with a waste collection business) won a tender to process recyclables from the Town of Cottesloe.

The SMRC tender responses must remain confidential and commercial in confidence prior to and during the tender invitation process, and therefore I respectfully request that representatives from the Cities of Cockburn and Kwinana consider disclosing an indirect financial interest relating to these discussions and support the proposed Motion above to allow the CEO to avoid disclosing commercial in confidence information to you, while remaining in compliance with the Local Government Act 1995
