FOGO IMPLEMENTATION STATUS REPORT

The first meeting of the project steering group was held on 14 December 2016. A risk assessment workshop was conducted on the 22 February 2017.

A communications working group with representation from all three participating member Councils has also been formed and an initial meeting was held in January. Ongoing meetings will be held bi-monthly.

MRA Consulting have been appointed to provide independent third party reviews and have commenced reviewing the draft communications strategy and project materials.

The residential areas in the City of Melville for the Stage 1 roll out have been selected based on demographics and operational rounds. The final list of serviceable properties is currently being assessed based on housing density, verge space and collection vehicle access.

CEO DELEGATED AUTHORITY 2017

The CEO's 15 delegated authorities were reviewed and approved. The CEO Performance Review Committee's delegated authority to appoint a HR Consultant was also reviewed and approved.

The SMRC has completed the Department of Local Government's annual Compliance Audit Return for 2016 and reported no non-compliance issues.

MID YEAR 2016-17 BUDGET REVIEW

Revenue from the sale of recyclables has achieved higher than expected commodity prices based on global markets and quarterly tender bids. The additional income has resulted in a net income of \$1 M above budget estimates.

Improved Waste Composting recovery rates has also achieved favourable results from the savings in residual transport and disposal budget costs and reduction in the 2016/17 insurance premiums has reduced operating expenditure.

Revised budget expenditure relates to the FOGO trial project and major non-routine maintenance previously accounted as Capital expenditure.

Overall the SMRC's revised budget closing funds has increased from \$300K to \$1.8Million.

WASTE SUPPLY AGREEMENT- CITY OF COCKBURN

The City of Cockburn has entered into a Waste Supply Agreement for delivering its MSW to the RRRC Waste Composting Facility following its withdrawal from the RRRC Project. The City of Cockburn and the RRRC Project Participants has also entered into a Deed of Settlement relating to the City of Cockburn variation to the RRRC project participants' Agreement as a result of Cockburn introducing a new waste collection regime from 7 October 2015.

FINANCIAL REPORTS

Higher operating revenues of \$650K, due to commodity prices and WCF tonnes received.

Lower operating expenditure of \$350K mainly due to unspent employee costs and maintenance. This has resulted in an \$1M budget surplus as at 31 January 2017
